

## SAFE TEEN DRIVER'S TEEN DRIVING CONTRACT

Here is Safe Teen Driver's Teen Driving Contract. Feel free to download it and adapt it to fit your teen driver's specific situation

### TEEN DRIVER'S RESPONSIBILITIES

I \_\_\_\_\_ promise to follow the rules and stipulations outlined in this contract and to adhere to any consequences should I fail to follow those rules and stipulations. I recognize that driving is a privilege and a responsibility and that this contract is created to ensure my safety and the safety of others while driving.

#### Teen Driving Responsibilities

1. I will drive only the car(s) I am allowed to drive.

2. I will honor any driving curfews set by my parents because I recognize that teen driving fatalities are far more common when driving after school and at night.

Consequence:

3. I will honor any limit of the number of passengers in the car as set by my parents because I know that just one additional passenger can dramatically increase the chance of a fatal car crash.

Consequence:

3. I will obey all traffic laws, including adhering to the posted speed limits on any road because I know that speeding accounts for 44 percent of all teen driving deaths crashes for teens ages 15-20.

Consequence:

4. I will properly use my seatbelt at all times while driving or riding in the car and insist that passengers riding with me use their seatbelt.

Consequence:

5. I will not drink any alcohol, use any illegal drugs or take any prescription medication from a doctor and then get behind the wheel of a motor vehicle. Nor will I get in a car with someone who has been drinking alcohol or using drugs. I know that drinking alcohol or using drugs impairs my ability to drive safely.

Consequence:

6. I promise to avoid using my cell phone while driving (I can pull over and talk on it), eat or drink in the car or engage in other distracting activities while driving.

Consequence:

7. I will let my parents know where I go in the car at all times.

8. I promise to properly care for the car including paying for insurance, repairs, routine maintenance and cleaning the inside and outside of the car regularly.

9. Should I receive a traffic ticket, I will be responsible for paying for it and any associated costs.
